

MIKE'S BIKES, LLC., DBA EAGLE BIKES RENTAL AGREEMENT AND POLICIES

Revised August 8, 2020



By initialing each statement below, I hereby acknowledge and agree to the following rental agreement terms and conditions:

_____ Eagle Bikes are rented out clean and in proper working condition and must be returned in the same manner. I have inspected my bike and agree it is in proper working condition.

_____ Eagle Bikes are maintained on a daily basis. It is the responsibility of the customer to check the bike at Eagle Bikes before setting out on any ride. I have inspected my rental bike and it is in acceptable condition.

_____ Eagle Bikes includes a helmet in the rental fee. Helmets are required to be worn at all times while riding the bike. If a customer is seen riding the rental bicycle without a helmet, they will immediately have to return the bike and will not receive any refund. I agree to wear my helmet at all times while riding the bike.

I, the Customer, agree to return the bike in clean, undamaged condition to avoid any additional charges for repair, maintenance or replacement. I, the Customer, accept use of the equipment as is, and I have noted the bike is in good condition. I accept full responsibility for care of the equipment while in my possession. Damaged parts or components will be repaired or replaced at Eagle Bike's discretion, and I agree to pay regular shop rates and retail prices for any components replaced. Clean condition means normal wear and tear is accepted but does not include broken spokes, rims, bent rims, damaged frames, handlebars, seats, or other parts from misuse and/or crashes.

All bikes should be returned clean of mud and debris. **As these are electric bikes, riders should avoid water.** If a bike is returned dirty, full of mud, or in a condition that shows it was ridden in water, there will be a minimum of a \$100 cleaning fee. If the bike is returned inoperable and shows evidence of mud or other indicators of having been in water, the \$300 deposit will not be returned, and a minimum of a \$100 cleaning fee will be assessed.

Hourly, Half Day and Daily rentals are due back by closing time. Late returns are subject to an assessment equal to the original rental fee.

I, the Customer, authorize Eagle Bikes to charge the credit card they have on file for me for \$300 for all eventual costs in case of damages to the bicycle(s) during my rental period, comprehensive of labor, except in the case that I can demonstrate other's faults with evidence and all necessary information for reimbursement. In case of theft, I will be responsible for reimbursing Eagle Bikes for the original price of the bicycle(s), plus the cost of any accessories that were provided at the time of the bike rental.
